## **Scope of Work:**

- A. Collect data of all projects under operation as well as under implementation from implementing agencies. Review the progress & updates provided by implementing agencies/ports and seek clarifications, if required.
  - a) Assist MoPSW in the Identification of various issues causing a delay in initiative progress and escalating the same.
  - b) Enhance data Visibility for better coordination and decision making.
  - c) Monitoring of Projects & Initiatives at MoPSW (Includes IT upgradation & Automation of Data capture and related portals like e-samiksha, shipping samvad, sagarmanthan etc.)
  - d) Compile & enhance information for various annual & periodic reports.
  - e) Promote the work of MoPSW by providing analysis and report.
  - f) Research and Data Analytics of data for enhanced decision making.
  - g) Assist MoPSW in the examination of all project issues and prepare a draft of the requisite communications.
  - h) Prepare presentations, reports, analysis summaries, etc. on initiative status/data, as required.
  - i) Facilitate and Conduct Meetings of MoPSW officials with stakeholders towards faster implementation of various initiatives outlined in **Annexure-I**.
  - j) Assist in the appraisal of new project proposals/initiatives including project concept review, etc.
  - k) Assist in RFP creation, vendor research, selection, contract negotiations, and transition management.
  - l) Identify sources, gather, compile data and information for the preparation of documents, guidelines, speeches, and position papers.
  - m) Assemble briefing materials and prepare PowerPoint and other presentations.
- B. Prepare all documentation/reports for all schemes/ projects of ministry.
  - Advise on long-term and short-term strategy to enhance the investments in ports, shipping & waterways and new avenues. Also, to assist in implementing the said strategy.
  - b) The team shall participate in progress review meetings, as and when required.
  - c) Assistance in building a strategy for promoting investments in shipping sector.
- C. Increasing visibility of India at international levels and strengthen maritime relations.
  - a) Follow up and facilitation of investment cases, interdepartmental/ organizational coordination, and MoUs signed during the Global Maritime India Summit (GMIS).
