4. Candidate is requested to report at the venue as per reporting time for the Power Point Presentation and Personal Interview. **No candidate shall be admitted for selection process after the commencement of the selection process.**
5. **Call letter for the Power Point Presentation and Personal Interview shall be sent by e-mail to the provisionally short-listed candidate separately. Please note that the call letters shall not be sent by post.** In case of non-receipt of call letter by e- mail, candidate should inform the undersigned vide e-mail career@udupicsl.com latest by **06 January 2025**.
6. Candidate should bring **two copies of the call letter, with recent passport size photographs pasted and a valid photo identity proof (in original)**. ONLY Passport/Election ID card/ Aadhaar/Driving license issued by the Government shall be accepted to secure entry to the Shipyard. **Those who do not produce the call letter and**

valid photo identity proof (in original) will not be allowed to appear for the selection process. One copy of the call letter is to be submitted to UCSL during the certificate verification. The candidate should retain the other copy of the call letter, till the completion of selection process.

Candidate short-listed for Power Point Presentation and Personal Interview should produce **print out of online application form (possessing unique registration number and photograph to be pasted), and all certificates in Original** towards proof of age, qualification, experience, caste, disability etc., **as well as one set of self-attested copy of all the certificates**, during the certificate verification and their candidature will be considered on the strength of the original certificates along with the Call Letter and valid Photo ID. **Those who do not produce the original certificates or online application form will not be allowed to appear for the selection process.**
