2. As per clause VI (a) of the vacancy notification, the method of selection for the following workmen posts comprises of tests as under: -

4. **Short-listed candidates should ensure that they fulfill all the eligibility requirements viz. age, qualification, experience, caste, disability etc, as advertised vide notification no. CSL/TSL/PROJ/HR/01/2021 dated 19 April 2021 before appearing for the Selection tests (Objective and Descriptive type test/Practical/Skill tests).**
5. For provisionally short-listed candidates, call letter for the selection tests shall be sent to e-mail ID mentioned in the online application. **Non-receipt of call letters, if any, shall be informed by email to tebmahr@tebma.co.in latest by 17 Mar 2022. Please note that the call letters will not be sent by post.** Other instructions are detailed in the call letter. Candidates are requested to go through the general instructions in the call letter, before appearing for the selection.
6. **Candidates should bring two copies of the call letter, with recent passport size photographs pasted and a valid photo identity proof (in original). ONLY Passport/Election ID card/ Aadhaar/ Driving license issued by the Government, shall be accepted to secure entry to the venue. Those who do not produce the call letter and valid photo identity proof (in original) will not**


be allowed to appear for the selection tests. One copy of the call letter is to be submitted during the selection tests. The candidates should retain the other copy of the call letter, till the completion of selection tests.

7. **Candidature is provisional subject to verification of certificates for proof of age, qualification, experience, caste, disability etc. at the time of joining or at some other stage.** If at any stage, the candidates short- listed above are found not meeting the eligibility requirements or fail to produce certificates in original or if at any stage, it is found that any information furnished by the candidate is false/ incorrect, the candidate shall not be considered for selection and candidature will be cancelled /rejected without further notice.
8. **In the present context of Covid-19 pandemic situation, the candidates are informed to strictly abide by all safety and security instructions while inside the premises and follow the instructions as listed under: -**
 - a) **All candidates attending the selection tests should undergo Rapid antigen test or RTPCR test (for those who are symptomatic and antigen negative) and produce negative test result (taken within 48 hours) for attending the selection process.**
 - b) **The above clause shall not be applicable for those candidates who have taken two doses of COVID vaccination, subject to submission of the vaccination certificate. However, those who are symptomatic shall undergo the above tests and carry the negative test results.**
 - c) **All candidates travelling inter-state/inter-district should strictly follow the extant guidelines of district administration / government / ICMR prior to attending selection tests.**
 - d) **It is advised to avoid crowded public transport to the extent possible. Maintain social distance while using such transport and wear personal protective like mask, goggles, gloves etc. and avoid touching the surfaces using naked hands.**
 - e) **All candidates seeking entry into venue shall wear appropriate face masks properly covering their nose, mouth, chin etc. The candidates shall remove the mask at gates for identification. **THOSE CANDIDATES WITHOUT FACE MASKS SHALL NOT BE PERMITTED ENTRY INTO VENUE.****
 - f) **All candidates seeking entry into the yard have to stand in the spaces marked at the Gates, entrances etc. so that social distancing as per norms can be ensured at these locations. **NO CROWDING AT GATES FOR ENTRY/EXIT SHALL BE PERMITTED.****

- g) **All candidates shall avoid touching any pillars, bars, hand rails etc.**
 - h) **Compulsory screening shall be done for all candidates entering through gates with thermal scanner.**
 - i) **Wearing of masks, social distancing and queue system shall be strictly adhered.**
 - j) **Any candidate with positive test results or found to have fever and cough with breathing problems are liable to be stopped / denied entry / permission to attend the selection tests.**
 - k) **All candidates shall bring their own mask, personal sanitizer (50ml), transparent water bottles / other refreshments, stationery items and avoid sharing of such items.**
 - l) **Movement to any other areas / buildings / work sites other than the venue of tests shall be strictly prohibited.**
9. **Possession and use of electronic devices such as Camera, Mobile Phone, Micro Phone, Digital watch or any other associated accessories, Calculator, Log Tables, Pager, Digital diary books, other electronic gadgets etc. are strictly prohibited in the examination hall. If any candidate is found in possession of any these devices / documents, his/her candidature is liable to be cancelled.**
10. **Candidates who are found engaged in malpractices or violating the instructions of the Invigilator in the examination hall shall be disqualified.**
11. **Candidates are requested to report on the date and reporting time as mentioned above for the tests.**
12. **Candidates are advised to frequently visit CSL website (Career page) for all updates related to the selection tests.**
13. **Please note that request for changing the date, time and venue of the selection tests shall not be entertained.**
14. **TSL reserves the right to extend the scheduled date or postpone / re-schedule the selection tests to the following day or a later date, due to any compelling / administrative reasons and candidates are advised to plan accordingly.**
15. **No correspondence regarding the rejection of application in case of ineligibility shall be entertained.**

16. The call letter is provisional and does not constitute an offer of appointment and mere attending the tests shall not entitle the candidate to any claim for employment in TSL.
17. Any changes in the above schedule shall be notified on CSL website only.
18. Other terms and conditions of the Vacancy notification No. CSL/TSL/PROJ/HR/01/2021 dated 19 April 2021 shall apply.
