IV. Period of Contract and Place of Posting: -

- a) The above post is **for a period of 5 years** subject to project requirements and individual performance.
- b) The posting shall be at Hooghly Cochin Shipyard Limited (HCSL), Howrah, West Bengal.

V. Remuneration:

Monthly remuneration shall be commensurate with the experience of the selected Candidate and shall be the best in the industry for the right candidate.

VI. Age:

Age shall be 50 years and above and subject to maximum of 65 years as on 28 February 2025.

VII. <u>Method of Selection:</u>

- a) The method of selection shall be through Personal Interview to be held at Cochin Shipyard Limited, Kochi.
- b) HCSL reserves the right to scrutinize applications for the post and prepare shortlist of candidates based on meeting eligibility requirements ascertained through the certificates submitted and only such shortlisted candidates shall be permitted to attend the selection process.

VIII. Conditions:

a) **Qualification**

The minimum qualification stipulated for the posts must be from a University/Institute/Examination Board recognized by AICTE/ appropriate statutory authority/State/Central Government.

b) **Experience**

- i) Experience acquired after the date of passing of the qualification stipulated as per the above shall only be considered. Period of post qualification experience shall be reckoned as on **28 February 2025.**
- ii) <u>Candidates should produce all certificates in original to establish the experience claimed in their online application, failing which their candidature shall be cancelled and they shall not be considered for further selection.</u>

- iii) Applicants who are presently working in any company (Private / Public Sector /Govt), in the absence of experience certificate, should submit copy of Appointment Order or Offer letter issued by the company, latest Pay Slip or copy of last Pay drawn as proof of experience. For past employment, experience certificate indicating the date of joining as well as relieving should be submitted. The candidates should submit all certificates to establish the experience claimed in their online application, failing which their candidature shall be cancelled and they shall not be considered for further selection.
- iv) Applicants should clearly specify the nature of work performed and duties, responsibilities handled in the respective jobs, as well as experience certificate in proof of the same shall be submitted during certificate verification.

The facility to submit their application can be accessed through our website www.cochinshipyard.in (Career page) from 29 January 2025 to 28 February 2025. Application submitted direct or by any other mode shall not be accepted.
- Applicants should ensure that all the entries in the online application have been correctly filled in and application submitted successfully. Change in the data provided in the application after final selection of the same through online will not be considered. Filling of garbage/junk details in any of the fields can lead to rejection of application.
- iv) Application must be complete in all respects as per this Advertisement Notification. Please note that incomplete applications /withdrawn applications / applications in draft status shall not be considered. On successful submission of the application, the status of the application shall be shown as "In process". After submission of the application, the candidate shall log in to My Applications and ensure that the application status is "In process" to ensure the process is complete.
- v) After applying through online, applicants should retain a soft copy/printout of the online application containing the unique registration number generated by the system for their reference. d) General

- i) Applicants are advised to make sure that they are meeting the eligibility requirements as per the vacancy notification for the post before submitting the applications.
- ii) HCSL reserves the right to call for any additional documentary evidence from candidates in support of educational qualification / experience / other notified eligibility requirements as indicated in their online application, and information/ replies such queries should be only through the e-mail careers@hooghlycsl.com. However, HCSL shall not be responsible for any delay/non-receipt of such e-mails within the stipulated date and time. Replies to any such queries received after the stipulated date and time shall not be considered, and no further correspondence shall be entertained in this regard.
