who do not produce the call letter and Aadhaar Card (in Original) shall not be allowed to appear for the Video Conferencing and further selection.

7. All instructions related to the selection process are detailed in the call letter. Candidates are advised to go through the call letter in detail

Original Certificates of the short-listed candidates shall be verified at the time of joining or at any other stage as decided by UCSL. **Candidature is provisional subject to verification of certificates for proof of age, qualification, experience, caste, disability etc. and meeting the notified eligibility requirements.** At the time of certificate verification/joining, if the candidates short- listed are found not meeting the eligibility requirements or fail to produce certificates in original or if at any stage, it is found that any information furnished by the candidate is false/ incorrect, or there has been suppression of facts and information, the candidate shall not be considered for selection and candidature/appointment will be cancelled/rejected without further notice.
9. Further to the Power Point Presentation, the candidates shall be shortlisted based on the work experience and job requirements as notified, to attend the Group Discussion & Personal Interview and the candidates shall be informed separately through website / Email.
