- 2. As per clause VII B of the above-referenced vacancy notification, the method of selection shall be through an Objective test followed by **Practical Test/Descriptive Test for Workmen**. - 5. Candidates appearing for the test should produce two copies of the Call Letter and a valid photo identity proof (in original). ONLY Aadhaar/ Election ID Card/ Passport/ Driving license issued by the Government shall be accepted as photo identity proof to appear for the selection test. Those who do not produce the call letter and valid photo identity proof (in original) will not be allowed to appear for the test.

- 6. Candidates should **paste recent passport-size photographs** and put their signatures in appropriate places in both copies of the call letter.
- 7. One Copy of the call letter is to be submitted to the invigilator at the time of the test. The candidates should retain the other copy of the call letter, till the completion of the selection process.
- 8. Candidature is provisional subject to verification of certificates for proof of age, qualification, experience, caste, disability etc., and meeting the notified eligibility requirements, at the time of certificate verification/joining. If the candidates shortlisted are found not meeting the eligibility requirements or fail to produce certificates in original or if at any stage, it is found that any information furnished by the candidate is false/incorrect, or there has been suppression of facts and information, the candidate shall not be considered for selection and candidature/appointment will be canceled/rejected without further notice.
