#### IV. Age:

a) Age shall be 50 years and above and subject to maximum of 65 years as on **03 March 2021**.

#### V. Method of Selection:

a) The method of selection shall be through Personal Interview to be held at Cochin Shipyard Limited, Kochi or Interview through electronic media in view of Covid-19 pandemic issues.

#### VI. Conditions:

#### a) Qualification

The qualification for the post must be from a University/ Examination recognized by AICTE/ appropriate statutory authority in India.

## b) **Experience**

- i) Experience acquired after the date of passing of the qualification stipulated as per item I above shall only be considered. Period of post qualification experience shall be reckoned as on **03 March 2021**.
- ii) <u>Candidates should produce all certificates in original to establish the experience claimed in their online application, failing which their candidature shall be cancelled and they shall not be considered for further selection.</u>
