Highlights – Shipbuilding (01 Jan '22 to 31 Mar '22)



- Hon'ble Vice President of India, Shri M Venkaiah Naidu visited INS Vikrant, the first indigenous aircraft carrier being built for Indian Navy;
- The third sea trials of the Indigenous Aircraft Carrier (IAC) was conducted for a duration of 7 continuous days from 09th to 15th January, 2022;
- CSL delivered the second lot of three Floating Border Out-Post (FBOPs) vessels out of Nine FBOPs being built for Ministry of Home Affairs, Govt. of India;
- Delivered 1 No. of Mini Bulk Carrier of 8000 DWT to JSW Shipping & Logistics Private Limited. The vessel named "JSW Manikgad" is the fourth and the final vessel in series of four vessels built at CSL for JSW;

Highlights - Shipbuilding (01 Jan '22 to 31 Mar '22)



- Launched 3 Nos. of Electric Hybrid 100 Pax Water Metro ferry for Kochi Metro;
- Keel laid 7 Nos. of Electric Hybrid 100 Pax Water Metro ferry for Kochi Metro;
- CSL entered into a contract with HS Service GMBH & Co. KG to build 8 Nos. of HS Eco Freighter 7000 DWT vessel. Approximate value of the contract is Rs.750 crores.
- CSL signed contract with Dredging Corporation of India (DCI) to build India's largest Dredger, 12,000 m3 Trailing Suction Hopper Dredger (TSHD), in collaboration with IHC Holland for an overall project cost of around Rs. 800 Crores;
- Official sea trial of 1 No. of 500 passenger cum 150 MT cargo vessel, "Nalanda" for A&N Administration was conducted from 22nd to 26th March, 2022. The vessel was second in the series of two vessel and the first one vessel was delivered on

Infrastructure Projects

International Ship Repair Facility (ISRF)

- Shiplift 130 Mr x 25 M x 6000 T with 4 work stations
- Estimate Rs. 970 crores
- Repair of 80 additional vessels a year. Increase in Repair throughput by around 70%



Present Status



- Overall physical completion of CME works 78%
- Due to financial difficulties faced by the contractor appointed for ISRF project. The contract for construction works was eventually terminated on 04 Feb 2022.
- CSL is presently in the process of appointing alternate contractors for completing the remnant works of ISRF project. No cost overrun is envisaged on account of this.
- All other actions are progressing without any change.

Infrastructure Projects

New Dry-Dock

- 310 Mtr x 75/60 Mtr x 13 Mtr & Other Allied Facilities
- Estimate Rs. 1799 Crores
- Construction of Complex, Technology Intensive large vessels such as LNG Carriers, Offshore Drillships, Aircraft Carriers, Offshore Rigs, Semi-submersibles etc.



Present Status



- Overall physical completion 60%
- Covid-19 pandemic and its after-effects such as disrupted material supply chain, exodus of migrant labourers, increased site safety protocols, Force Majeure claims by International suppliers etc. affected the progress of works.
- Purchase order for 600T Gantry Crane was issued to M/s. Hyundai Samho Heavy Industries Co. Ltd., South Korea on 14 March 2019. Fabrication works of crane commenced in August 2021 and is in progress.
- Tender enquiry for two jib cranes of capacity 75T and 40T published on 07 Dec 2021 and evaluation of bids is in progress.
- Revised targeted commissioning date July 2023.

Hooghly Cochin Shipyard Limited (HCSL) at Howrah



- CSL holds 100% stake in HCSL
- HCSL setting up a shipbuilding/ ship repair unit at Nazirgunge and Salkia in Howrah.
- The Yard at its Nazirgunge unit is now ready for operations.
- Facility targets construction and repairs of the Inland Water and Coastal Vessels – will cater to emerging demands of the NW-1, NW-2 and NW-5 sector.



Udupi Cochin Shipyard Limited (UCSL) at Malpe



- A wholly owned subsidiary of CSL acquired through CIRP in Sep 2020. The name of Company was subsequently changed from Tebma Shipyards Limited to Udupi Cochin Shipyard Limited.
- Facilities at Malpe, Hangarkatta and Chengalpet.
- Total investment ₹80 Crs.
- Hangarkatta facility operationalised in July 2021.
- The activities for operationalising the Malpe facility is progressing.
- Facility targets construction and repairs of small vessels viz., tugs, fishing vessels etc.








PROFIT AFTER TAX (Rs Cr.) & PAT MARGINS (%)
